Release, Waiver, Indemnification, Hold Harmless, and Assumption of The Risk Agreement

In return for permission to participate in or observe any of the activities of the Terrace Rod & Gun Club (TR&GC), and/or to enter upon or use any of its premises or facilities, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, I, the undersigned ("Undersigned"), for myself, and/or on behalf of the undersigned minor ("Minor"), as parent and/or natural or legal guardian of Minor, hereby agree as follows:

Minor and Undersigned (on behalf of Undersigned and Minor) agree to indemnify, hold harmless, and defend the Terrace Rod & Gun Club, the International Defensive Pistol Association (IDPA), and any and all of their owners, lessees, directors, officers, match officials, members, employees, agents and servants, and any and all sponsors, donators, contributors, landowners, and participants (hereinafter referred to collectively as TR&GC in any activities of the Terrace Rod & Gun Club and IDPA, from any and all fault, liabilities, costs, expenses, claims, demands, actions, judgments, and/or lawsuits, arising out of, related to, or connected with the discharge of firearms, TR&GC's ranges, buildings, land, equipment, and/or any facilities, premises, and/or equipment owned, managed, leased, and/or supervised by TR&GC (hereinafter referred to collectively as "Premises"), Undersigned's and/or Minor's presence on or use of Premises, or Undersigned's and/or Minor's participation in this event. Further, should any such claim, demand, or lawsuit arise or be asserted in any way whatsoever related thereto, whether arising under the laws of British Columbia, Canada, or under any theory of law or equity, Minor and Undersigned (on behalf of Undersigned and Minor) will indemnify, hold harmless, and defend TR&GC from any and all costs, expenses, and/or liability, including, but not limited to, the cost of any settlement or judgment made or rendered against TR&GC, whether individually, jointly, or in solido with Minor and/or Undersigned, together with all costs of court and other costs or expenses incurred in connection with any such claim, demand, or lawsuit, including any and all attorney's fees.

Minor and Undersigned (on behalf of Undersigned and Minor) hereby waive for themselves, and their executors, administrators, assignees, heirs, next of kin, and beneficiaries, any and all rights and claims for damages, losses, demands, and any other actions whatsoever, which they, individually or in solido, may have, or subsequently claim to have, or which may arise against TR&GC (including, but not limited to, any and all injuries, damages, death, and/or illnesses suffered by Minor and/or Undersigned, any theft, unexplained disappearance, and/or damage which may befall any personal property or property accompanying Minor and/or Undersigned, while en route to, participating in, and/or while en route from, any activities of the TR&GC at any location), which may, in any way whatsoever, arise out of, be related to, or connected with the Premises (including any latent defect in Premises), Minor and/or Undersigned's presence on or use of the Premises, Undersigned's and/or Minor's participation in this event, Minor's or Undersigned's property (whether or not entrusted to TR&GC), and/or the discharge of firearms. TR&GC shall not be liable for, and Minor and Undersigned (on behalf of Undersigned and Minor), on behalf of themselves and their executors, administrators, assignees, heirs, next of kin, and beneficiaries, hereby expressly release TR&GC from, any and all such claims.

Minor and Undersigned (on behalf of Undersigned and Minor) hereby certify that they have previously used, and are familiar with, firearms, and are aware of all potential hazards and risks inherent to the use of firearms and/or physical proximity to any shooting activity, including, but not limited to, accidental discharge of firearms, ricochets, defective handloads, flying fragments, and any resultant personal injury and/or damage to property. **Minor and/or Undersigned (on behalf of Undersigned and Minor) hereby expressly assume the risk of entering the Premises and/or of taking part in any activities on the Premises** which include, but are not limited to, the discharge of firearms and firing of live ammunition.

Minor and Undersigned (on behalf of Undersigned and Minor) acknowledge that they have received, read, understand, and will at all times abide by Terrace Rod & Gun Club and/or IDPA, range rules and procedures. Minor and Undersigned (on behalf of Undersigned and Minor) acknowledge the right of any Match Official(s) to terminate their participation immediately upon any failure to fully comply with all rules, regulations, and/or official instructions, by Undersigned, minor, and/or any of their guests. Minor and Undersigned (on behalf of Undersigned and Minor) hereby certify that they are not prohibited by any federal, state, and/or local laws and/or regulations from possessing or using firearms.

Undersigned (on behalf of Undersigned and Minor) hereby certifies that they have read and fully understand the foregoing Release, and freely enter into it on behalf of Undersigned and/or Minor, and their executors, administrators, assignees, heirs, next of kin, and beneficiaries. Undersigned (on behalf of Undersigned and Minor) hereby agrees that all terms hereof are contractual, and not mere recital, and that they have signed this Release after reading it, and of their own free act. This instrument binds Undersigned, Minor, and their executors, administrators, assignees, heirs, next of kin, and beneficiaries.
